4. First Aid Measures

<u>Inhalation:</u>	Gargle. Remove from exposure area to fresh air immediately. Perform artificial respiration if necessary. Keep person warm and at rest. Treat symptomatically and supportively. Get medical attention immediately.
<u>Eyes:</u>	Wash eyes immediately with large amounts of water, occasionally lifting upper and lower lids, until no evidence of chemical remains (at least 15-20 minutes). Get medical attention immediately.
<u>Skin:</u>	Remove contaminated clothing and shoes immediately. Wash with large amounts of water until no evidence of chemical remains (at least 15-20 minutes).
<u>Ingestion:</u>	If vomiting occurs, keep head lower than hips to help prevent aspiration. Treat symptomatically and supportively. Get medical attention if needed.

5. Fire-Fighting Measures

7. Handling and Storage:

Handling:

Set up the local exhaust ventilation and the collection dust equipment or handle in a place where ventilation is good. Set up the equipment to wash eyes and to wash the body near the handling place in case of emergency. Prevent dust from dispersing when working. Work from the windward about work in outdoor. Wash hands and face etc. well after handling.

Storage:

Avoid water and moisture, and keep in an indoor warehouse. Seal up the remainder of product after a package is opened in a plastic bag.
